

Jeep Official Rules

This draw is run and administered by “M/S Dhofar Automotive LLC, Sultanate of Oman, in collaboration with, and sponsored by Jeep Middle East (“Jeep”) (together referred to as the “Sponsors”). By entering the prize draw (“Draw”), you (“you” “your”) agree to be bound by these terms (“Official Rules”), and by the decisions of the Sponsors, relating to the Draw.

The Sponsors reserve the right to update these Official Rules from time to time and any updated version will be effective as soon as it is published on the Dealer’s website www.jeep-oman.com.

1. HOW TO ENTER

- 1.1 Subject to the eligibility criteria set out below, you will be eligible to enter the Draw upon purchase of a brand-new Jeep vehicle from an authorised Dealer in the Eligible Country (defined below), between [April 1st, 2022] to [June 30th, 2022] (“Entry Period”). Only purchases made during the Entry Period will be valid and any purchases or entries made outside of the Entry Period shall be automatically disqualified.

2. ELIGIBILITY

- 2.1 To participate in the Draw:

- (a) **Residency:** You must be a resident in Oman (“Eligible Country”).
- (b) **Minimum Age Restrictions:** You must be at least 18 years of age.
- (c) **Excluded Individuals:** You must not be an employee, officer, director, contractor, agent, or representative of the Sponsors (collectively, the “Excluded Individuals”), or any immediate family members (parents, children, siblings, and spouses) of the Excluded Individuals or any other persons with whom the Excluded Individuals reside.

- 2.2 In entering the Draw, you confirm that you are eligible to do so and eligible to claim any Prize you may win, and that all information submitted by you is true, current, and complete.

- 2.3 The Sponsors may require you to provide proof that you are eligible to enter the Draw.

3. THE PRIZE AND DRAW

- 3.3 The winners of the Draw will be selected within 7 days from the last day of the Entry Period.
- 3.4 The winner will be notified by email and must provide an acknowledgment notice (by responding to the email) within 7 days to claim the Prize. If a winner does not respond within 7 days of being notified, then the winner's Prize will be forfeited, and the Sponsors will be entitled to select another winner in accordance with the process described above.
- 3.1 The Prize is non-exchangeable, non-transferable and no cash alternative is offered. The Sponsors reserve the right to replace the Prize with an alternative Prize of equal or higher value. The winner confirms that it will not utilise the Prize for commercial purposes (for example but not limited to, the Prize cannot be resold or auctioned).
